## **Organizational Summary:**

### **Position Description:**

The River Restoration Specialist works with the Senior Ecologist to advance channel and floodplain restoration projects along the middle and upper Sacramento River. The Specialist will work closely with River Partners' collaborators to plan, design, supervise, and monitor implementation projects funded by the US Bureau of Reclamation and other agencies. The River Restoration Specialist will be responsible for supervising restoration contractors during the implementation season to ensure that the contractors have the information and guidance necessary to complete projects on schedule and in budget. During the remainder of the year, the River Restoration Specialist will work with public agencies, landowners, other collaborators and the River Partners' Development team to develop grant proposals to fund new project activities and plan, design, permit, and monitor funded projects.

### **Essential Functions and Responsibilities:**

• Identify channel, floodplain, and riparian protection and restoration sites that are ecologically significant and develop successful proposals to fund restoration projects.

- Build effective partnerships and coalitions with a diverse group of stakeholders to advance River Partner's mission and projects.
- Write grants, submit bids, and negotiate cooperative agreements to secure the funding necessary to successfully implement River Partners' projects.
- Collaborate with the Director of Operations and the Director of Science to test and develop innovative restoration strategies.
- Oversee project management and ensure that activities, budgets and milestones are coordinated and updated on a frequent basis to ensure that project scheduling, spending and reporting can expeditiously support project objectives and billing cycles.
- Develop scoping requests for subcontract work and enter into agreements to ensure that cost and quality expectations are met.
- Interface with funders to ensure grant funds and project expenditures are coordinated and if necessary create and submit change orders in a timely manner to ensure that variances are properly communicated and funded.
- Support River Partners' President, Senior Managers, and Regional Staff in developing strategic plans, budgets, and marketing materials.
- Coordinate with agency staff and conservation partners in the successful implementation of River Partners projects.
- Actively participate in regional planning efforts including the Sacrament River Science Partnership, the Central Valley Salmon Habitat Partnership, the Central Valley Flood Protection Plan (DWR and CVFPB), the Battle Creek Working Group, and USFWS and CDFW endangered species recovery efforts, and local and regional water quality and supply initiatives.
- Initiate and direct changes to increase efficiency and meet objectives.
- Establish and coordinate productive partnerships with the agricultural community, conservation organizations, and local, state and federal agencies.
- Represent River Partners before the general public, elected officials, agencies, stakeholders, and non-profits to generate support for River Partners programs.
- Manages, directs, assigns, supervises and evaluates the work of biologists
- Other duties as requested.
