The Conservation Project Manager will work with the SLT team to coordinate conservation goals and outcomes to support SLTs mission of protecting the lands we love.

### RESPONSIBILITES

- Work with SLT staff and Land Acquisition Committee, landowners, public agencies, and partner organizations to identify, fund, and develop land conservation projects involving forest, agriculture, headwaters, and wildlands in Siskiyou County.
- Work closely with existing Conservation Projects Manager, Grant and Administration Coordinator, Stewardship Manager, and Executive Director to carry out conservation work and effective project management.
- Positively interact and develop relationships with landowners from diverse backgrounds, through consistent and professional correspondence and follow up.
- Negotiate and draft conservation easements, baseline reports, management plans and associated agreements with project partners.
- Create and development maps and GIS data for project development and management, data analysis, and education and outreach.
- Conduct appropriate record keeping, progress tracking, budgeting, due diligence, and reporting for each project to comply with SLT's policies and Land Trust Alliance Standards and Practices for accreditation.

- Research and apply for funding opportunities for projects that support SLT's mission and priorities.

The Conservation Project Manager position reports to the Executive Director and generally does not supervise other staff. However, he/she may oversee sub-contractors, project tasks requiring SLT staff support, and volunteers.
