- Have additional \$2.5M in funding for future rounds



- Capacity and Partnership **Building** Focused
- Up to 2-year projects
- Applications Due **Sep. 20**
- Only 1 round of funding

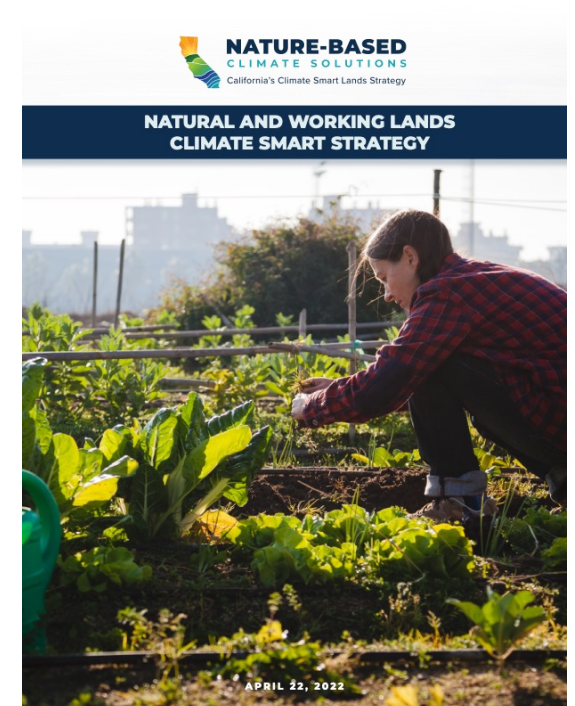
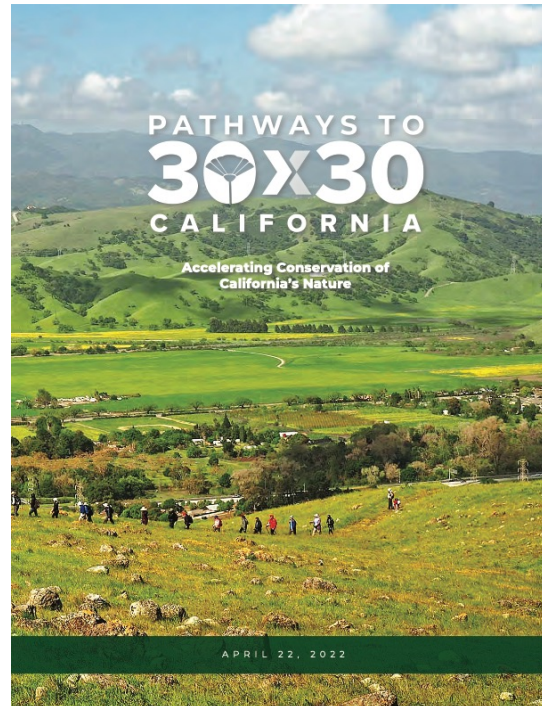

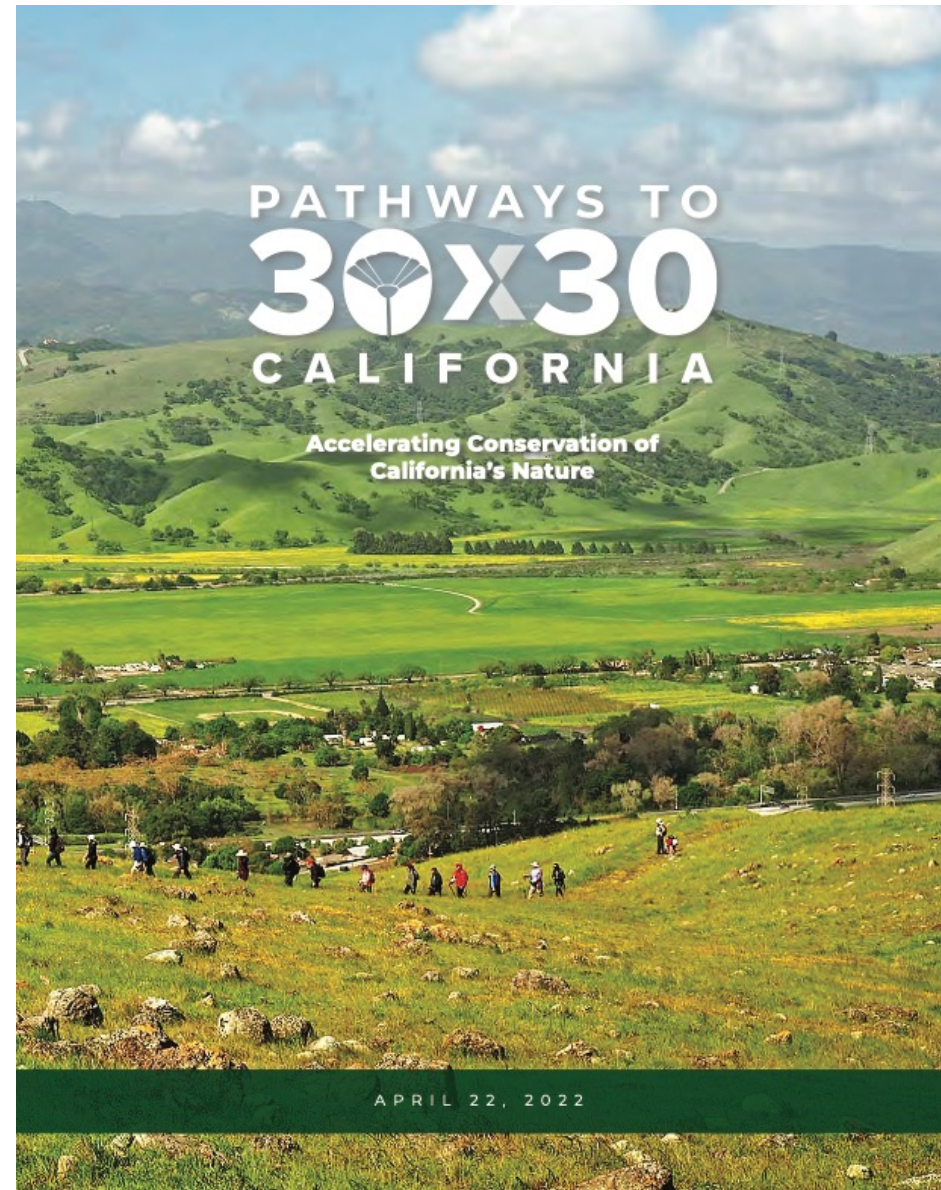


Pathways to 30x30

California's strategy to conserve an additional six million acres of land and half a million acres of coastal waters is organized into ten pathways:

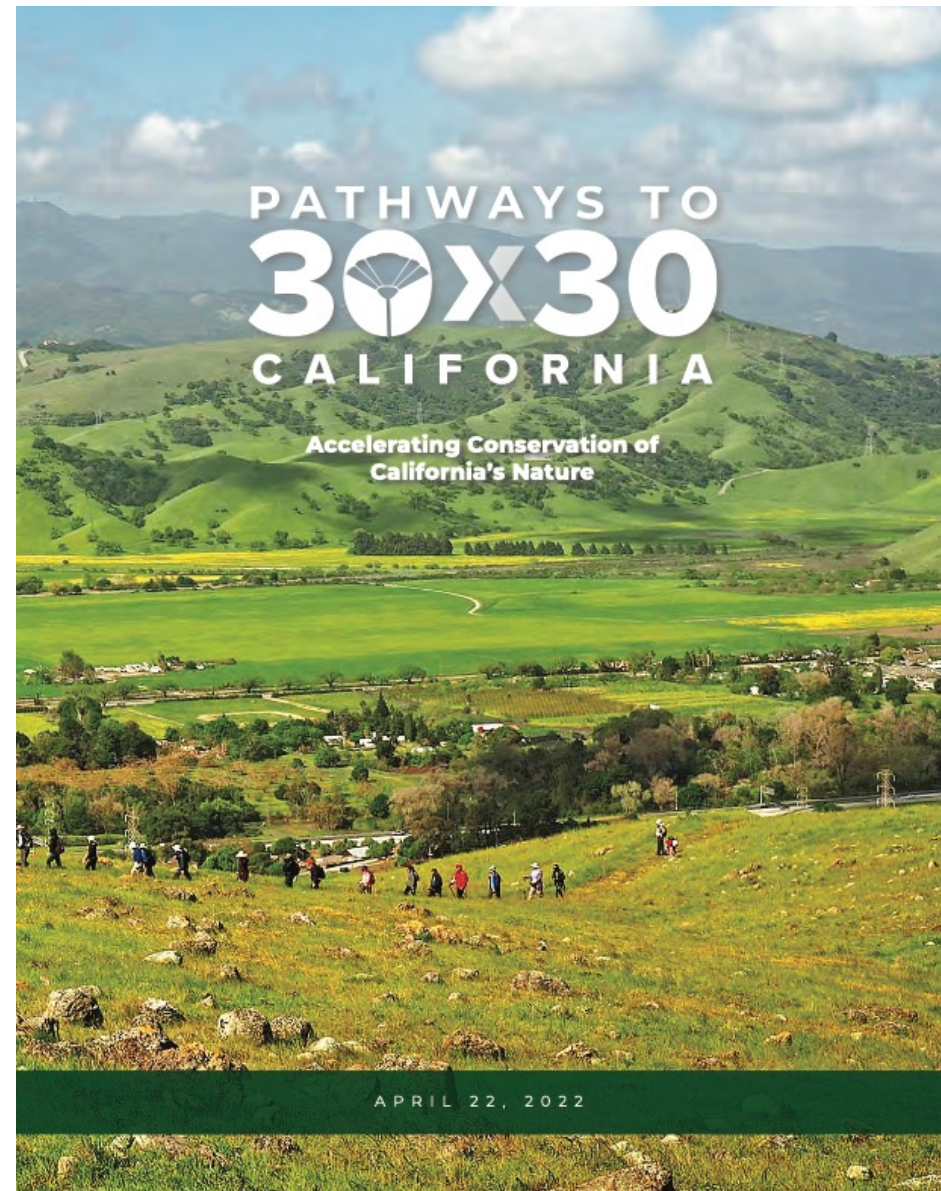
1. Accelerate Regionally Led Conservation

Natural and Working Lands Climate Smart Strategy (NWLCCSS)

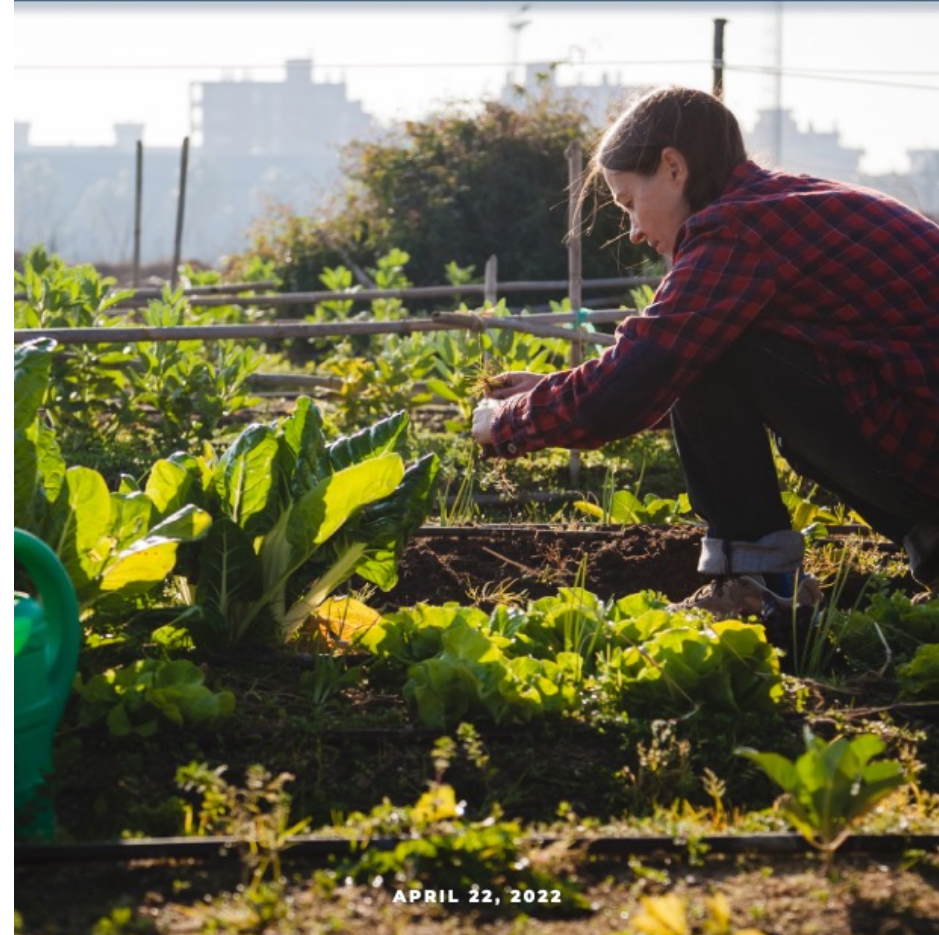
Priorities to increase climate action on California's natural and working lands:

1. **Accelerate on-the-ground projects** that deliver climate benefits through nature-based solutions across California's diverse landscapes that state agencies and partners can learn from and that can be scaled-up over time.
2. **Invest in science** to improve our understanding of implementation pathways here in California and to help scale nature-based climate solutions around the world.

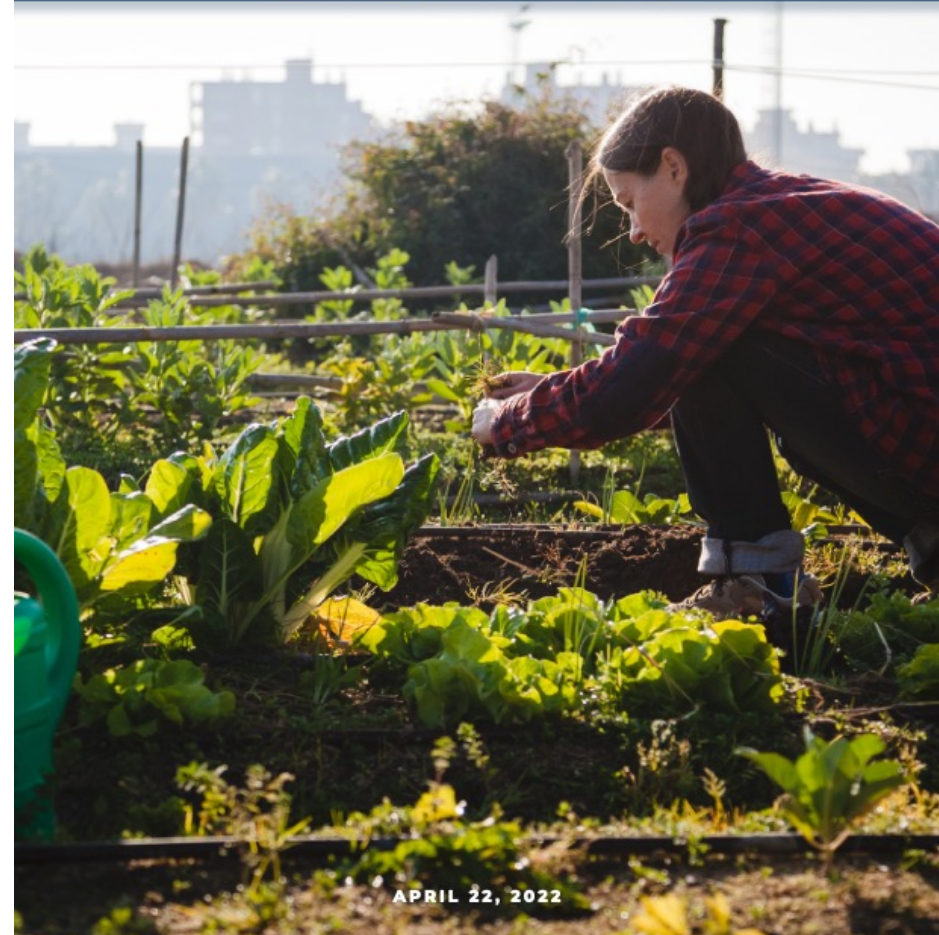

3. **Prioritize equity** to drive solutions that help those residents and communities hit first and worst by climate change impacts, including through targeted funding, workforce development, capacity building, and support for tribally-led nature-based solutions.
4. **Scale investment** to support climate action in the natural working lands sector, including through public-private partnerships, demonstration projects, and leveraging federal funds.
5. **Build capacity** of implementation partners through approaches including technical assistance and focused support, grant funding opportunities, and partnering with California Native American tribes.

6. **Improve internal coordination** among state agencies to align and leverage funding, authorities, and programs to accelerate implementation of nature-based solutions.
7. Strengthen collective action by **advancing new and innovative partnerships** with nonstate government groups and leaders, and through organizing annual updates and periodic convenings on implementation.

CCLT Goals:

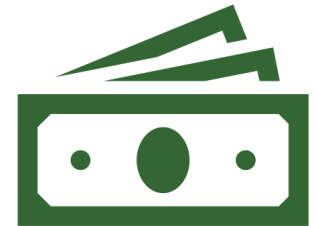
1. Build a pipeline of over 1 million acres of conservation projects that directly contribute to the goals of 30x30 and the NWLCSS
2. Support projects that provide a direct benefit to underserved communities
3. Support partnerships between land trusts and Native Tribes/organizations
4. Support land trusts and partners to leverage \$7 million in non-state funding toward projects

What does “leveraging funding” mean?

- What outcomes will your project lead to?
- How many community partnerships will you be able to build?
- Of those partnerships, how many are underserved or disadvantaged?
- What other funding – in kind or \$\$ - will you be able to access when you have more capacity?
- What other funding will you be able to access through your partnerships?
- What planning processes will lead to future expansion or capacity?
- What new grant applications will you be able to access?

Think expansively throughout your organization about both direct and indirect benefits.

Funding



- Maximum of \$1.0 million *in this first round*
- Reserve Funding
 - 40% (\$400,000) reserved for projects located in or directly benefiting Underserved Communities and/or Native-led land trusts or projects that include authentic partnerships with Tribes or Native-led organizations
 - Deadlines can be extended for Reserve Funding applications, but you must contact us by October 18 to alert us of your intent to apply

***Most awards will be between \$25,000 - \$150,000 (contact us for projects outside of this range).
Each land trust may only submit one (1) application (with or without partners).***

Eligibility

- **California Land Trusts**
- **California Land Trusts in partnership with:**
 - Tribes
 - Native-led Organizations
 - Community Based Partners
 - California 501(c)3 non-profit organizations
 - Government agencies/Special Districts
 - Resource Conservation Districts (RCD)
 - Universities/Colleges
- *Applicants do not need to be members of CCLT*
- ***Non-member land trusts are encouraged to learn more about the benefits of membership on the CCLT website (calandtrusts.org)***

Each land trust may only submit one (1) application (with or without partners). Projects must be located within the State of California.

- Rolling Deadline for Partnership Proposals or Proposals from Native-led Land Trusts
 - Applications from Native-led land trusts, or applications that include partnerships with underserved community organizations and/or Tribes or Native-led organizations have a rolling deadline and may be submitted any time.
 - Funding is limited and will be provided as applications are received.
 - You must contact the Program Director by October 18, 2024 to inform us of your intent to apply.

This Grant Agreement ("Agreement") is made and entered into as of the last date signed below (the "Effective Date") by and between California Council of Land Trusts ("CCLT") and [Insert Grantee Name] ("Grantee"), collectively the "Parties" and individually, a "Party."

WHEREAS, CCLT desires to provide technical assistance and support capacity building for land trusts through its CA Onward Grant Program;

WHEREAS, in pursuit of that goal, CCLT has obtained a grant from the Wildlife Conservation Board to fund subgrants as part of the CA Onward Grant Program;

NOW THEREFORE, in consideration of their mutual promises set forth in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound, hereby agree as follows:

1. DEFINITIONS

1.1 The following capitalized terms used in this agreement shall have the meanings defined in this section:

- Final Report means the report described in Sections 7.2(b) and (c) of this Agreement.
- Funding Agency means the Wildlife Conservation Board, which provided all or a portion of the funds granted pursuant to this Agreement.
- Grant Project Description means the description and scope of the work funded by the grant under this Agreement, as set forth in Exhibit A.
- Project means the work described in the Grant Project Description.
- Progress Report means the quarterly report described in Sections 7.2(a) and (c) of this Agreement.

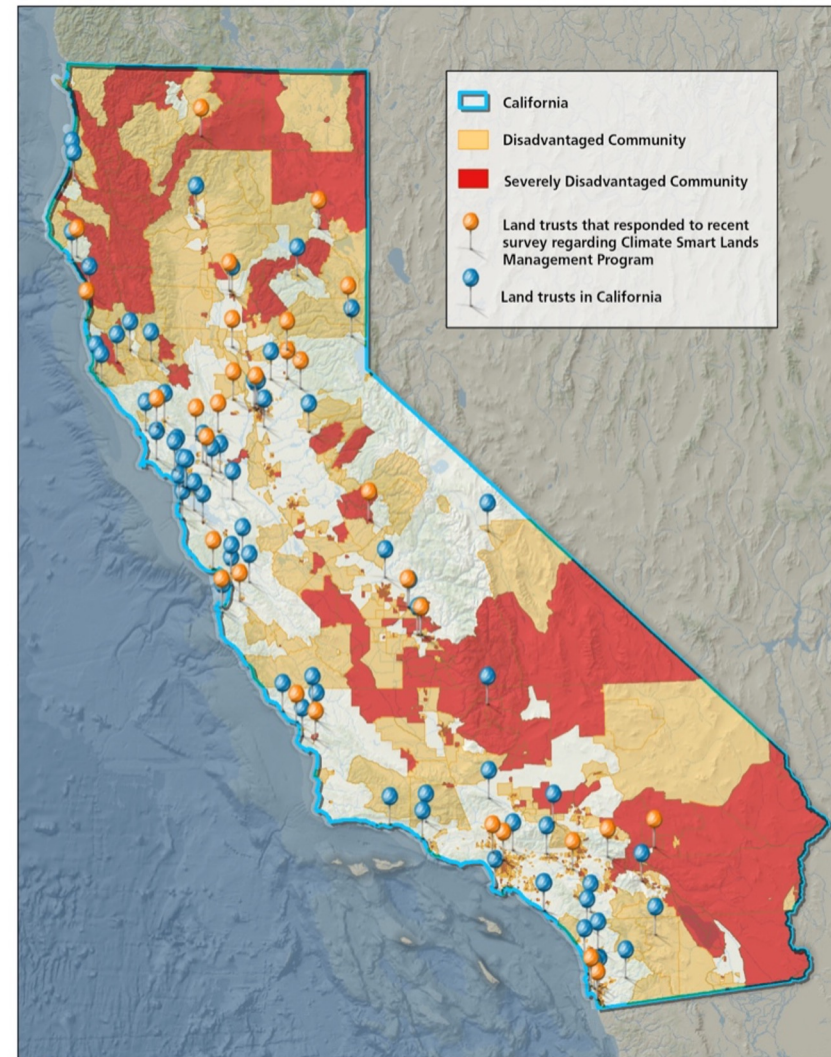

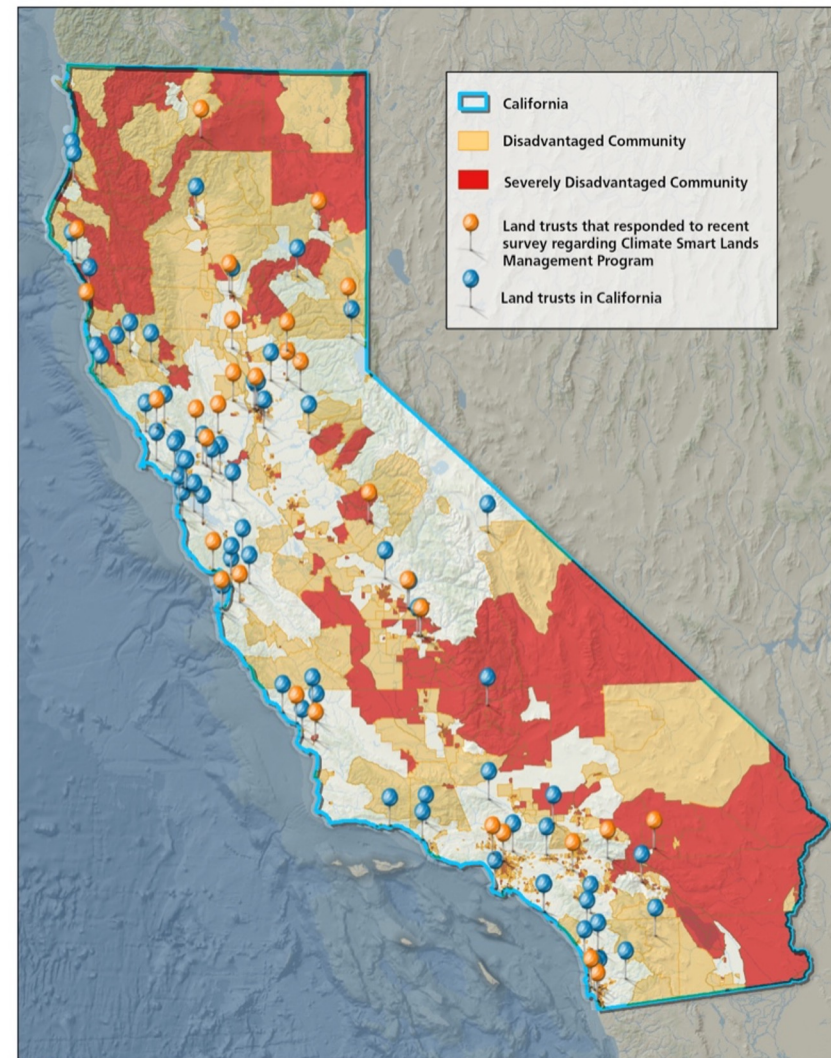

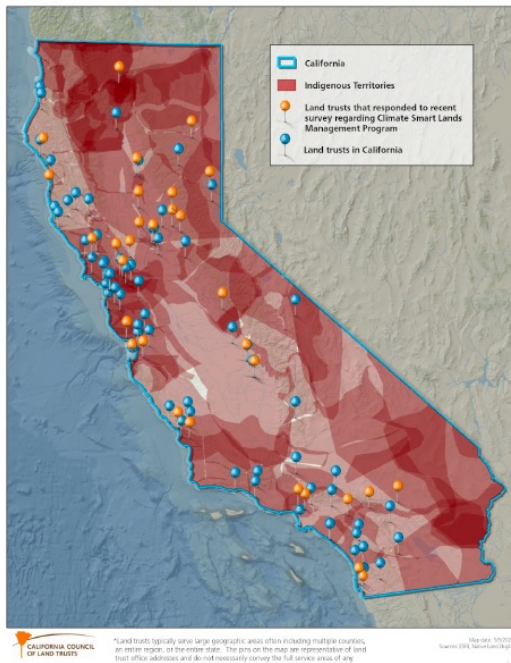

Ineligible Costs

Grant funding may not be used for the following:

- all costs incurred outside of the grant agreement term
- general operating support, including rent or other office expenses
(unless part of budgeted indirect rate)
- accreditation or membership fees
- insurance premiums, property taxes, or other state/local/federal taxes
- land or easement acquisition costs
- endowments, legal defense, or reserve funds
- restoration costs and ongoing management/stewardship costs
- projects mandated to address a violation of, or an order to comply with, a law or regulation
- event sponsorship or event fundraising
- travel costs that do not adhere to state guidelines, out-of-state travel costs
- food, beverage, or entertainment costs
- fines, penalties, damages, and other settlements resulting from violations or noncompliance

Review Process

- Applications will go through an administrative review for eligibility
- Eligible applications will then be reviewed by a Grant Review Committee (GRC)
- The GRC may request applicants revise and resubmit applications
- Applicants are strongly encouraged to consult with the Program Director prior to submitting applications to minimize necessary revisions
- Proposals will be scored by multiple reviewers in accordance with the grant evaluation criteria
- Other aspects used to determine final grant decisions
 - Geography
 - Focus areas
 - Impact on Native and/or under-resourced, underserved, disadvantaged, and severely disadvantaged communities
- May be recommendations for partial funding
- *CCLT will notify all applicants of final decisions*

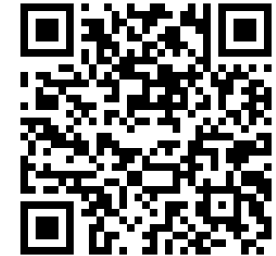
